Release:

I hereby release, remiss and forever discharge from any claim and liabilities whatsoever without limitations that I might have against FOREST GLEN BIBLE CAMP authorized playing field (wherever located and whenever I might play) or related activities and any operator or their personnel hereafter called the Sponsors and Property Owners, procedures and liabilities arising out of connection with, or resulting from playing the game, including without limitations, those resulting from the manufacturer, selection, delivery, possession, use, or operation of such equipment. I hereby release the Sponsors and Property Owners from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to the Sponsors and Property Owners that I am in good health and do not suffer from a heart condition or other ailments which could be exacerbated in playing the game.

Assumption of Risk:

I confirm that I have specific insurance to cover any injuries that I may sustain or cause to others and that FOREST GLEN BIBLE CAMP or their employees will not be held responsible for any injuries sustained, and I have read and fully understand the terms of this agreement. **THIS IS FULLY INTENDED TO BE A LEGAL CONTRACT FOR ONE YEAR.
